

PRIVACY POLICY AND LEGAL NOTICE

I. PRIVACY POLICY

In compliance with REGULATION (EU) 2016/679 OF THE EUROPEAN PARLIAMENT AND OF THE COUNCIL of 27 April 2016, on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and in compliance with Organic Law 3/2018 of 5 December, on Personal Data Protection and the guarantee of digital rights, you are hereby informed that the personal data provided by you through the website <http://www.gaiacamp.com> (hereinafter, the "website") and through the mobile application GAIA CAMP will be processed under the following terms:

Data controller

Purposes of the processing

- To inform you about our products and services, whenever you may request such information through the forms of the website or the mobile application and/or via email.
- To respond to and manage your consultations, comments and suggestions, whenever applicable.
- The number of visited pages, the number of visits and the activity of visitors and their frequency of use are analysed to obtain information about how the website and the mobile application are used. For these purposes, the DATA CONTROLLER uses statistical information prepared by the Internet Service Provider, which does not allow the data subject to be identified at any time.

Legitimate basis

Consent. The personal data obtained through the forms of the website and the mobile application will only be processed based on the consent given by the data subject by acknowledging acceptance in the box provided for this purpose. This consent can be withdrawn at any time.

Legitimate interest of the controller. The statistical information obtained from the website will be processed based on the legitimate interest of the controller. This information does not allow the user to be identified.

Recipients

The personal data obtained through the website will not be communicated to third parties, unless there is a legal obligation to do so.

Storage

The personal data provided by the user for receiving commercial communications will be stored as long as the data subject does not request that it be erased or does not withdraw their consent.

When a user may send their data to contact the CONTROLLER, to make consultations or to make suggestions, the data will be stored as long as necessary for such purpose and as long as there could be liability due to the processing.

Traffic data, statistical data and visits to the website: data will be stored for a period of three years.

Rights

Policy on the protection of minors
